





#### Superintendent's Message Janet Sifferman, Superintendent



In December of 2012 the Michigan State legislature passed Public Act 437 of 2012. This law negated the contract Hartland Consolidated Schools had with the State of Michigan through the Michigan School Bond Loan Program, which set the debt levy for bonded debt at 7.6 mills.

Public Act 437 of 2012 requires school districts to adjust the debt levies based on a new formula that, in the case of Hartland Consolidated Schools, will raise the levy. This levy will be calculated in late May or early June of each year based on the taxable value of property within the school district boundaries. The levy for 2014, which was set this past June, will be 8.29 mills. You will see this in your December tax bill.

While we at Hartland Consolidated Schools believe in fiscal responsibility, we disagree with the way in which this increase occurred. It was a law passed in the legislature with little or no notification to the taxpayers. Due to this action, our Board of Education is forced to levy this amount.

We are scheduling a public hearing to discuss this matter and answer any questions the public may have at our Board of Education meeting scheduled for *September 8, 2014 at 6:30 p.m.* in the Boardroom at the Hartland Educational Support Service Center. Our financial advisor from Stauder Barch & Associates, as well as our school bond attorney from Thrun Law Firm will be in attendance.

pharmaceutical research and development.


### Carmine Finelli

Although student pictures are considered "Directory Information" for which a release is unnecessary, we would like to confirm your permission in order to use your child's photograph or electronic image in the manner described above.

#### Notification of Rights under FERPA

The Family Educational Rights and Privacy Act (FERPA) affords parents and students over 18 years of age ("eligible students") certain rights with respect to the student's education records. They are:

1) The right to inspect and review the student's education records within 45 days of the day the District receives a request for access.

a. Parents or eligible students should submit to the school principal [or appropriate school official] a written request that identifies the record(s) they wish to inspect. The principal will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.

2) The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate or misleading.

a. Parents or eligible students may ask Hartland Consolidated School District to amend a record that they believe is inaccurate or misleading. They should write the school principal, clearly identify the part of the record they want changed, and specify why it is inaccurate or misleading.

b. If the District decides not to amend the record as requested by the parent or eligible student, the District will notify the parent or eligible student of the decision and advise them of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.

3) The right to consent to disclosures of personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without consent.

a. One exception which permits disclosure without consent is disclosure to school officials with legitimate educational interests. A school official is a person employed by the District as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the School Board; a person or company with whom the District has contracted to perform a special task (such as an attorney, auditor, medical consultant, or therapist); or a parent or student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his or her tasks.

b. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

c. Upon request, the District discloses education records without consent to officials of another school district in which a student seeks or intends to enroll. [NOTE: FERPA requires a school district to make a reasonable attempt to notify the student of the records request unless it states in its annual notification that it intends to forward records on request.]

4) The right to file a complaint with the U.S. Department of Education concerning alleged failures by the District to comply with the requirements of FERPA. The name and address of the Office that administers FERPA is: Family Policy Compliance Office ; U.S. Department of Education; 600 Independence Avenue, SW; Washington, DC 20202-4605

The Family Educational Rights and Privacy Act of 1974 provides that the following information may be released upon request: student's name, date of birth, phone number, address, parent name(s), school of attendance, picture(s), video(s), publication of student picture(s), with name attached, artwork and school activity group(s). In order to comply with this legislation, the district requests that parents, emancipated minors and those students 18 years of age and over, who do NOT wish release of this information, mail written notice by September 30, 2013 to Hartland Consolidated Schools, 9525 E Highland Road, Howell, MI 48843.







#### TOWNSHIP SEEKS RESIDENTS TO SERVE ON PARKS TASK FORCE

#### 12 Reasons Not to Give Property to Your Kids Now

When asked about planning for future long term when asked about plaining for future forg term care costs or nursing home costs, some people say "I'm not worried. I'll just give it all to my kids before I need care." That sounds easy, but will it work? Read on for twelve reasons **not** to give all your property to your kids now.

Reason #1: You can't spend any of the money. Acason #1: You can't spend any of the money. What if you need or want some of the money later? Once you give it to the kids, you are not entitled to even the income from it. Not the interest, not the farm income, not the dividends, not the property rents---nothing. If you want money you have to ask your kids.

Reason #2: You can't sell the assets. Let's say you put your home in your kids' names. Then, a few years later, you decide you would like to downsize or move to a warmer state. Can you sell it? Not without getting your kids' permission and signatures. You may think of it as your home, but legally it is not yours any longer.

#### Reason #3: You can't make decisions about how where to invest.

Do you enjoy managing your investments or savings so you get the best interest rate or the best return on your money? Or maybe you have some return on your money? Or maybe you have some farmland and enjoy making decisions about the farm. Well, once you give the property to your kids, you don't have the power to manage the prop-erty. Legally, your kids will manage it for you. You can make suggestions about how they should handle it, but they do not have to follow what you

Reason #4: You can't give money to grandchildren, charities, or others. You worked hard all those years, sayed, invested

You worked nard all mose years, saved, invested wisely, and now you would like to give some of your money away. Maybe to help a grandchild with college—maybe to buy a car for another

grandchild-maybe to pledge to your church's building fund. Whatever it is, guess what? If you gave your assets to your kids, you do not you gave your assets to your kids, you do not have the power to give it to anyone or spend it on anyone. You have to ask your kids if they will do it for you. If they still have the money (and they have not spent it yet), then they can decide whether they want to do that. Legally, it's the incrementary are do this do increased. or spend it its' their property now and their decision

#### Reason #5: The kids might spend it.

Reason #5: The kids might spend it. Maybe you gave the kids money and expected them to keep the money in the bank, "in case I need it." Well, once you give it to the kids, it's their money, not yours. Legally, they can spend it all, every last dime. And there's nothing you can do legally to stop them.

#### Reason #6: The kids' creditors can come

after it. after it. Are your kids wise with money? Do they ever get in over their head, or could they? Once you give property or money to your kids, it's theirs, which means that a creditor can also come after them. If they later have financial problems, the money you gave them could end up going straight to the creditors to pay off their debts.

#### Reason #7: Your money may go to your ex-

Reason #7: Your money may go to your ex-daughter in law in a divorce. Suppose you give money to your son. He takes the check to the bank and puts it in the joint account he has with the wife. A couple of years pass and one day his wife comes home and tells him "I want a divorce. I don't want to be mar-ried anymore." As they go to court, the property you gave your son may be part of the divorce battle. Under Michigan law, when gifts or inher-itances are co-mingled with the spouse's funds, the judge presumes your son intended to give his ex-wife half of those assets. So, it will be a battle in divorce court. That is, unless the daughter in law spent all the money before the divorce

### Reason #8: Your child may pay a higher income tax bill.

Do the assets that you want to give your child generate income? Maybe interest, dividends, capital gains, rents, farm revenue? Someone has to pay the income tax on those earnings has to pay the income tax on those earnings. Once you give the assets to your child, then the child will be the one getting the income tax bill in the future. This may be a big shock to the child. Not to mention the fact that the child may pay higher taxes than you did as a retiree on a fixed income.

#### Reason #9: If your child dies, he property goes where they want.

goes where they want. Okay, let's say you decided to give all of your assets to your kids. What if one of the kids dies before you do? Where do the assets go? They go according to your child's estate plan (Will, Trust, etc.) The child may leave it to his or her spouse or kids or even someone totally outside the family. Is that what you would want? Well, it doesn't matter what you want since those are no longer your assets. They belong to your child and your child can do with them what he wants.

#### Reason #10: Property taxes on your h

Reason #10: 110perce will go up. For many families, the equity in their home is a large part of their wealth. So, what happens if you give your home to your kids yet you plan to continue to live there? By transferring the home to your children, you may end up with a home to your children, you may end up with a much larger real estate tax bill. Why? You no longer own the home so you no longer get a homestead exemption. Plus, you might not receive other property tax exemptions, like

those going to disabled veterans or disabled per-

Reason #11: Capital gains tax goes up. Have any of your assets increased in value? Such as your home, farmland, stocks, rental houses, or other property? If you sold the asset now, you might owe capital gains tax at a 15-20% tax rate. However, if you keep those assets until your death, then the capital gains tax is wined out death, then the capital gains tax is wiped out through what the IRS calls a "step up in basis." This means that the value of the asset at the date

This means that the value of the asset at the date of your death becomes the new value for deter-mining if there was any gain to be taxed later. Now what if you give the assets to your kids while you are alive? By doing that you missed out on the tax benefit at death and, instead, they get the tax bill to be paid later when they sell the property property

Reason #12: You do not have a crystal ball. Reason #12: You do not have a crystal ball. Do you know when you will need care in a nurs-ing home? If you do, then you have a lot of plan-ning options available. But most people don't know when they might need care. And if you don't know when you'll need care, how do you know when to give your assets to your kids? If you give your assets to your kids? If know when to give your assets to your kids? If you give your assets to your kids and then need care within 5 years of the gift, you may have no way to pay for any care—no Medicaid because of the improper gift, and no assets in your name because you gave them all away.

Bottom line, you don't want to give the assets away too soon or too late. If you give the money too soon, you may want or need it later. If you too soon, you may want or need it later. If you give your money away too late, you may be left without any care or resources at all. The Chamber recipients were chosen in large part due to their contribution to the community, academic achievement, financial need, and well-composed essays.






