JOB DESCRIPTION

TITLE: CREW LEADER – ELEMENTARY SCHOOL

QUALIFICATIONS:

1. High School diploma or equivalent
2. Good character, cooperative nature, and good communication skills.
3. Demonstrated aptitude for successful fulfillment of assigned performance responsibilities.
4. Ability to take direction, plan tasks and delegate responsibilities.
5. Must be able to work independently.
6. Manage: inventory of food, paper, and cleaning supplies.
7. Must be comfortable with basic computer applications.
8. Must be able to handle money and complete paperwork.
9. Must have experience in cooking, baking, following recipes, and food service operations.
10. Must have demonstrated the necessary abilities through job shadowing, substituting, and job sharing, etc.
11. Certification of good health, including lifting of up to 50 lbs., evidence of freedom from physically limiting back problems, signed by a licensed physician.
12. Demonstrated record of good attendance.
13. Must understand and follow all HACCP guidelines.
14. Must have a working knowledge of how to use and care for equipment.
15. Must be well groomed, pleasant, and tactful, and have the ability to work effectively with students and adults.
16. Must pass ServSafe course and test per State Guidelines.

JOB GOAL: To provide students and staff with elementary quality, nutritional meals by following the National School Lunch Program Guidelines and Regulations.

PERFORMANCE

RESPONSIBILITIES: The Elementary School Crew Leader will perform duties in the following areas which are listed by way of example, and are not to be considered to be all inclusive.

1. Manage and assist in the preparation of meals.
2. Ordering food and staples for the elementary school kitchen from appropriate vendors as stipulated by the bid.
3. Keep all records of lunches served, money collected, production reports, inventory, HACCP documentation, and any other accounting records.
4. Manage staff: work schedule and time cards, assist/oversee the training of any new elementary school kitchen staff member.
5. Guide and direct daily substitutes as necessary.
6. Ensure that all procedures in HACCP guidelines for food safety and sanitation are followed.
7. Must be able to attend monthly crew leader meetings.
8. Other duties as assigned.
