#### **MAINTENANCE I TECHNICIAN**

### Job Description/Qualifications

Maintenance I Technician carries out all tasks of repair and/or replacements of Building & Grounds components, mechanical systems, electrical apparatus and plumbing systems within their ability as directed by the Director of Operations, Maintenance Coordinator, Custodial Supervisor or his/her designee. Maintenance I personnel will also be qualified to carry out duties of custodial or utility personnel as needed within the district.

To become a Maintenance I Technician, a qualified candidate must show experience assisting with Maintenance type work. This person must also attain the required score on the Maintenance Department examination. At the point of proof of an individual within the bargaining unit being duly qualified for a Maintenance I Technician position, this person will be able to apply for a Maintenance I Technician position as a position becomes available within the district.

All contract requirements set forth within the bargaining unit must be met with regard to an individual moving from one position to another within the bargaining unit.

A qualified candidate outside of the bargaining unit must prove three years of experience and pass the Maintenance examination to the Maintenance I level.
