CALL TO PUBLIC

Superintendent Sifferman noted that January is Board Appreciation Month across the state. While a more formal celebration will take place at the January 27 meeting, Ms. Sifferman thanked the Board for their continued guidance and service. She then introduced Mikki Cheney, principal of Farms Intermediate School, who updated the Board and public on the various happenings at Farms. She highlighted the expansion of the Readers' and Writers' Workshop programs, including the addition of a two-hour block. Dotty Selix presented data showing increased success in the 7th grade writing assessments since the expansion of the workshop programs. Several writing samples

BOARD REPORTS

Motion by Hutchinson, supported by Sinelli that the Board of Education, upon the recommendation of the Superintendent offers a probationary teaching contract to Emily Smak for the 2013/14 school year at the Step 1, BA salary tract, pending verification of credentials and Public Acts 99, 83 & 189 requirements, if applicable. Motion carried 5-0. Ms. Smak was introduced by Principal Cheney and Assistant Principal Day.

NEW HIRE - SMAK (FIS)

Motion by Kaszyca, supported by Gatewood that the Board of Education, upon the recommendation of the Assistant Superintendent for Business & Operations and the Director of Operations, adopts the participating resolution for the 2013/2014 MSBO/MAPT Bus Purchasing Program and authorizes the purchase of six buses through said program for a total of \$542,113.32 as presented. Motion carried 5-0.

BUS PURCHASE

President Dumond noted that in addition to electing officers, the Board also needs to determine committee assignments. He asked if anyone had preferences, that they get those to him. Ms. Sifferman noted that there are Finance and Curriculum Committee meetings scheduled for this week. Mr. Dumond noted these could go forward as currently assigned.
