2022-2023 MEAL PRICING ANNOUNCEMENT

3-23-22

Last week, the Federal government did not include free meals for all students in their current spending bill. As a result, next school year, we will return to the traditional paid meal system. Families can still apply to receive meals at free or reduced prices. Only those students who have an approved application for the 2022-23 school year or have been directly certified by the State of Michigan will receive free or reduced priced meals for the 2022-23 school year.

Questions?

- Q. Will students still receive free meals for the remainder of this school year?
 - A. Yes, breakfast and lunch meals will continue to be free for all students for the remainder of the 2021-22 school year.
- Q. Will families be able to apply for free or reduced-price meals next year?
 - A. Yes, families that meet the Federal income eligibility guidelines will be able to apply to receive meals for free or reduced price.
- Q. What will the cost of meals be next school year?
 - A. The USDA regulates the cost of paid meals through the National School Lunch Program. We have not yet received the pricing guidelines for the 2022-23 school year. We do however anticipate that there will be a price increase from previous school years. As soon as we know next year's meal prices, we will communicate those with the district and parents.
- Q. When can I apply for my student to receive free or reduced-price meals for the 22-23 school year?
 - A. The application for free or reduced priced meals cannot be filled out before 7/1/22. The online application will be available on the Hartland Schools website at the beginning of August. You can also receive a paper copy of the application by downloading it from the website or requesting one from the district.
- Q. What if I do not fill out an application or get approved for free or reduced-price meals?
 - A. If your student does not have an approved application on file or has been directly certified by the state of Michigan, then you will be charged full price for all meals.
- Q. How do I know if my student has been directly certified by the State of Michigan to receive free or reduced-price meals?
 - A. If your student has been directly certified to receive free or reduced priced meals, you will receive a letter in August letting you know that you do not need to fill out an application. If you do not receive a letter, you must fill out an application.
- Q. My student was approved for free meals in the past, do I need to fill out a new application?
 - A. Yes, you must have a newly approved application on file every school year.

- Q. If I wait until after school starts to fill out an application, does it back date to the start of the school year?
 - A. No, your student can not begin to receive free or reduced-price meals until the application has been processed and approved. Any meals received prior to the approved application will be charged at full price.
