Motion by Aberasturi, supported by Costa that the minutes of the March 8, 2021 regular meeting be approved. Motion carried 7-0.

SUPERTINTENDENT'S REPORT

Superintendent Hughes reminded everyone of the upcoming Board Tour on April 28th. The tour will start at the Middle school at 9:00, Creekside at 9:30, Village at 10:00, then Round at 10:30.

A Finance Committee meeting has been scheduled for May 4th at 7:30 am.

A Special Board of Education meeting has been scheduled for May 19th at 8:00 a.m.

BOND UPDATE

Superintendent Hughes introduced Matt Marino who gave an update on the Robotics Center and Auxiliary Field Bond projects. Matt reminded everyone that updates are posted regularly on our website. Superintendent Hughes thanked the Robotics parents for their input on the design.

Superintendent Hughes responded to questions about mask waivers for the fall and stated that there is no waiver at this time.

HCS DIVERSITY, EQUITY, & INCLUSION UPDATE

Superintendent Hughes addressed the Diversity, Equity, and Inclusion committee information that was posted on social media and on WHMI and assured everyone that the full Board is 100% committed to having a DEI Committee. The Board is having discussions about what the subcommittee structure will look like.

Superintendent Hughes introduced High School Principal Kate Gregory to talk about end of the year activities for seniors. Principal Gregory said due to not being able to guarantee attendance numbers with Eastern for a ceremony, she is planning a drive-thru graduation ceremony like last year on Saturday June 5th, with a rain date of June 6th. Seniors last day will be May 19th and she is putting together a plan for the Senior walk. She said the High School administration is also planning a senior formal event for Friday May 14th.

EXTENDED COVID-19 LEARNING PLAN

Superintendent Hughes introduced Assistant Superintendent of Curriculum Dave Minsker. Dave talked about the "Thinkstretch" Summer Learning Packets that will be provided for students, Pre-K through 8th grade to self-pace throughout the summer. The program includes literacy, science, math, stem, and engagement activities along with an awards ceremony in the fall. The cost of the program will be covered by COVID money.

Superintendent Hughes addressed parents concerned about the number of times kids must quarantine. He has been working with the HEA and Kate Gregory to come up with a plan, where students will have the opportunity to move to virtual learning with a commitment through the end of the school year.

Scott VanEpps shared that the average K-12 student attendance 3/8/21 through 4/9/21 was 93.82%.

Superintendent Hughes wished the juniors good luck on the SAT test tomorrow.

Superintendent Hughes presented the Board members with the book "The Tribe".

"THINKSTRETCH" SUMMER LEARNING PACKET PURCHASE

Motion by Kenrick, supported by Coleman, that the Board of Education, upon the recommendation of the Superintendent and the Assistant Superintendent of Curriculum and Instruction, approves the purchase of the "ThinkStretch" Summer Learning Packet program in the amount of \$33,390.00 as presented. Motion carried 7-0.

CREEKSIDE ELEMENTARY PLAYGROUND EQUIPMENT - PTO PURCHASE

Motion by Coleman, supported by Hemeyer, that the Board of Education, upon the recommendation of the Assistant Superintendent for Business & Operations, approves the purchase of new playground equipment for Creekside in the amount of \$28,545.46 as presented. Motion carried 7-0.
