## **BOARD REPORTS & REQUESTS**

The Board thanked the High school staff, administrators, students and parents for a great homecoming weekend.

## **PAYMENT OF INVOICES**

Motion by Coleman, supported by Hemeyer, that the Board of Education, upon the recommendation of the Chief Financial Officer, approves the financial report as of September 30, 2022, and the payment of invoices totaling \$4,968,635.70 and payroll obligations totaling \$4,032,061.94. Motion carried 7-0.

## **2022-23 BOARD GOALS**

Motion by Hemeyer, supported by Glabach, that the Board of Education, upon the recommendation of the Superintendent, approves the 2022-23 Goals as presented. Motion carried 7-0.

Mr. Dumond recommended adopting goals over the summer, before the start of the school year.

## **NEW HIRE**

Motion by Glabach, supported by Hemeyer, that the Board of Education, upon the recommendation of the Superintendent, offers a probationary teaching contract to Paige Patterson for the 2022/23 school year at the Step 3, BA salary tract (\$49,253), pending verification of credentials and Public Acts 99, 83 & 189 requirements, if applicable. Motion carried 7-0. Mr. Hughes let the Board know that Paige was unable to attend due to commitments in her current job and will be at the November meeting.

## **BAND INSTRUMENT PURCHASE (2020 BOND)**

Motion by Coleman, supported by Hemeyer, that the Board of Education, upon the recommendation of the Chief Financial Officer, approves the band instrument purchase as presented. Motion carried 7-0.

## **NEW AND REVISED POLICIES**

Superintendent Hughes noted the policy revisions are minor, with one new policy. The updates are in line with legal decisions and changes in Federal regulations to remain compliant.

## **NON-HOMESTEAD MILLAGE ELECTION**

Superintendent Hughes said the non-homestead millage will be a ballot proposal in the spring. This will affect non-homestead properties only. We need to get the millage back to 18. In November the Board will be asked to approve the ballot language.

## **PURCHASE OF BUILDING GENERATOR AND TIE IN CONTRACT**

Superintendent Hughes talked about the district looking into purchasing a second generator, since two buildings often lose power at the same time. The quotes that were received are cost prohibitive and he does not recommend purchasing one at this time. He will recommend updating the wire connections at each building along with the current generator at a future date.

President Costa noted that the next meeting will be held November 14, 2022, 6:30 p.m., regular, and December 12, 2022, 6:30 p.m., regular, Boardroom, Hartland Educational Support Service Center.
